#### **SUMMARY**

This memorandum serves as information pertaining to an administrative modification to the FY20204 Unified Planning Work Program (UPWP).

# **BACKGROUND**

# Chapel Hill Transit

The Town of Chapel Hill Transit Department will receive federal funding under FTA's Section 5310 Areas of Persistent Poverty Program. These funds will support the Chapel Hill Transit's efforts to financially plan and design a new, app-based, on-demand micro transit system to serve a two-mile corridor of the planned North-South bus rapid transit route. Inclusion of these apportioned funds in the FY2024 UPWP is required as documentation to drawdown these funds. The project and budget will be described in Appendix H.

# Town of Carrboro

The Town of Carrboro has requested a redistribution of its programmed STBG-DA funds between its task codes. This amendment does not represent a gain or loss of UPWP funds; it solely represents re-balancing of the existing budget associated with several task codes as outlined in Table 1.

# **II-B-2: Regional Planning**

## PURPOSE/OUTCOME

One of DCHC's core functions is guiding effective and efficient transportation infrastructure investment. The MPO advises its local, regional, state, and federal stakeholders to align their policies and actions though the North Carolina Comprehensive Transportation Plan (CTP) process and the USDOT required long-range Metropolitan Transportation Plan (MTP) process.

# **METHODOLOGY**

<u>Comprehensive Transportation Plan (CTP):</u> The MPO will conduct periodic reviews, amend, and monitor progress on CTP. The MPO will specifically work in Durham to amend the adopted CTP so that project problem statements include non-motorized improvements.

<u>Metropolitan Transportation Plan (MTP):</u> The MPO will conduct periodic reviews, amend, and monitor progress on the newly adopted 2050 MTP. The MPO will also work with regional partners to schedule and scope the 2055 MTP process.

<u>Planning Project Development:</u> The MPO will develop planning project elements of regional significance using its staff, or with the assistance of qualified consultants who have unique expertise in the project's focus area.

- **2.** Public outreach materials consistent with the MPO's Public Involvement Plan, initiating MTP outreach with goals and performance metric development.
