#### 8. Public Hearing for the 2040 MTP Amendment, draft FY16-25 MTIP, and CDR (20 min)

FY2016-2025 Metropolitan Transportation Improvement Program (MTIP) The draft FY2016-2025 Metropolitan Transportation Improvement Program (MTIP) was developed by the MPO LPA in the Spring 2015. The draft FY2016-2015 MTIP was developed in accordance with Federal and State laws and is consistent with the recently adopted State of North Carolina Statewide Transportation Improvement Program (STIP). The FY2016-2025 MTIP must be adopted prior to October 1, 2015 for the MPO to remain in compliance with Federal regulations for MPOs. The chapters and appendices of the FY2016-2025 MTIP are available on the MPO's website using this link: http://www.dchcmpo.org/programs/improvement/2025tip/default.asp 2040 Metropolitan Transportation Plan (MTP)

The MPO's MTIP must be a subset of the MPO's 2040 Metropolitan Transportation Plan (MTP). In order to maintain this relationship, some MTIP projects needed to be added to the 2040 MTP and several 2040 MTP projects needed to have the air quality threshold year, cost, project length or other data adjusted to match the FY2016-2025 MTIP. The proposed additions and changes to the 2040 MTP are listed in the attachment. This action was the first amendment to the 2040 MTP.

Conformity Determination Report (CDR)

In addition, federal regulations require the MPO to approve a Conformity Determination Report (CDR) for the amended 2040 MTP and the FY2016-2025 MTIP. This CDR is a short form because the MPO is not required to complete a corresponding regional emission analysis. See the 2040 MTP attachment, it contains information for the CDR. On June 10, 2015, the DCHC MPO Board approved the release of the three planning documents (discussed above) for public review and comment until July 31, 2015. An adverstisement announcing the public comment period for the planning documents was run on June 14, 2015 in the Herald Sun and in the Triangle Tribune. On June 25, 2015, the City of Durham ran a Press Release inviting citizens to review the three planning documents and submit comments. Announcements for the release of the three planning document were also made in early June 2015 on the DCHC MPO's website, Facebook page, and Twitter feed. Several public comments were received during the comment period. See the attachment for a compilation of public comments that were received during the public comment period. The three planning documents will be on the September 9, 2015 MPO Board meeting agenda for adoption.

### 9. <u>2014 Mobility Report Card (20 minutes)</u> Andy Henry, LPA Staff Kosok Chae, LPA Staff

The DCHC MPO released the Congestion Management Process - System Status Report 2014 for public comment in January 2015 and adopted the report in March 2015. That report provided the state of system performance and recommendations for future policy directions. LPA staff has also been developing the 2014 Mobility Report Card with significant input from local partners. The Report Card provides detailed performance, safety and activity data on the specific vehicle, transit, bicycling and pedestrian facilities in the MPO. In cases where consistent historical data is available, the Report Card provides a comparative analysis of the facility. The full report and executive summary for the Mobility Report Card, as well as a short presentation, are attached.

**TC Action:** Recommended that the Board release the document for a minimum 21-day public comment period.

**Board Action:** Receive the 2014 Mobility Report Card, provide comments, and release the document for a minimum 21-day public comment period.
