## FY2024 UNIFIED PLANNING WORK PROGRAM EXECUTIVE SUMMARY

### What is the Unified Planning Work Program (UPWP)?

The UPWP is a one-year funding plan developed by the DCHC MPO that allocates funding to support ongoing transportation planning activities of the MPO. It funds Lead Planning Agency staff hours and operating costs, as well as special projects and planning activities performed by MPO jurisdictions. It serves as a basis to determine other longer-term funding models allocated by the DCHC MPO, including the Metropolitan Transportation Plan and the Comprehensive Transportation Plan.

# Where does UPWP funding come from and how is it allocated?

Funding for the UPWP is provided on an annual basis by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA). FHWA funding sources include Surface Area Block Grants (STBG-DA) which are allocated to Transportation Management Areas over 200,000, and Planning (PL) funds. FTA funds include 5303 and 5307 grants, which provide assistance to transit agencies to conduct transit planning and technical studies related to urban area public transit. All of these funding sources require local jurisdictions to match a percentage of programmed funds using local money. FHWA funds require a 20% local match, with the FHWA providing 80% of funds, and FTA funds require a 10% match from the State and a 10% local match.

The MPO Board will hold a public hearing for the FY2024 UPWP during their March 8, 2023 meeting, during which time the public may comment on the contents of the FY2024 UPWP. After that public hearing, the Board will make their final vote for approval during their April 12, 2023 meeting.

## What are the Special Studies being programmed in the FY2024 UPWP?

The Town of Carrboro is programming \$3,000 to develop and use the recommendations from the Estes Road corridor study to determine the most suitable design for bike-ped improvements along the corridor as part of the development of EB-5994A. The Town will also continue to coordinate with the consultants for the downtown parking study to finalize recommendations and begin implementation.

The Town of Chapel Hill is programming \$16,000 to participate on new and ongoing special studies, including the 15-501 Corridor study, Transit-Oriented Development Study, Land Use Management Ordinance rewrite, N-S BRT, Triangle Bikeway Study, and other studies as needed.

The Town of Hillsborough is programming \$75,000 to engage a consultant to undertake a parking study for its downtown area. The scope of work will include adequacy of current facilities, turnover during peak times, estimated demand under a variety of redevelopment scenarios, adequacy of current ordinance requirements, and access for deliveries and unloading.

Orange County is programming \$114,167 to complete a short-range transit plan to enhance transit connectivity and efficiency for residents, visitors, and workers in the region.

The City of Durham is programming \$250,000 to manage an update of the City's 2017 Bike+Walk Implementation Plan, which will produce comprehensive pedestrian and bicycle network plans; updated prioritization of corridors, gaps, intersections, and new project types; additional project types, including bike boulevards and traffic calming; and cross sections and conceptual designs for priority projects of each type.

Durham County is programming \$180,000 to develop a County Comprehensive Bicycle, Pedestrian, and Greenway Plan. The plan will evaluate the bicycle, pedestrian, and greenway needs for the areas of the County that are outside of municipal boundaries and develop recommendations for future facilities.
