# 6. Draft FY2015-2016 Unified Planning Work Program (UPWP)

Annually, the DCHC MPO is required by federal regulations to prepare a Unified Planning Work Program (UPWP) that details and guides the urban area transportation planning activities. Funding for the UPWP is provided on an annual basis by the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA). The UPWP must identify MPO planning tasks to be undertaken with the use of federal transportation funds, including highway and transit programs. Attachment 12 is the draft FY 2015-2016 UPWP. The proposed schedule for UPWP development is as follows: draft FY2015-2016 UPWP will be presented to the MPO Board 15-103

on January 14, 2015 and released for public comment. The MPO Board will hold a public hearing on the draft plan on February 11, 2015 and approve the final FY2015-2016 UPWP on March 11, 2015.

The MTP / CTP subcommittee has been meeting since March 2014 to work on the Comprehensive Transportation Plan (CTP). Give the fairly recent work on the 2040 Metropolitan Transportation Plan (MTP), some of the first development requirements of the CTP such as Goals, Socioeconomic Data (SE Data) and modeling tools have been already completed. The subcommittee and MPO and NCDOT staff have drafted the next step, the Deficiency Analysis, and ask that the MPO Board release it for comment at their January 2015 meeting.

# 9. <u>Draft FY2015-2025 STIP Supplement (DCHC MPO's TIP)</u> Lindsay Smart, LPA Staff

Department of Transportation released the draft 10-year State Transportation Improvement Program (STIP), which schedules the projects proposed for full or partial funding across the state in the Final 2016-2015 STIP. The first five years of project programming is called the STIP and the latter five years of project programming is called the developmental program. The STIP is updated every two years.
