

**RESOLUTION TO REQUEST THE TRANSFER OF
FUNDS FROM FEDERAL HIGHWAY ADMINISTRATION (FHWA) TO FEDERAL
TRANSIT ADMINISTRATION (FTA)
FOR THE DURHAM-CHAPEL HILL-CARRBORO URBAN AREA**

September 14, 2022

A motion was made by Board Member _____ and seconded by Board Member _____ for the adoption of the following resolution, and upon being put to a vote, was duly adopted.

WHEREAS, Congestion Mitigation Air Quality (CMAQ) funds are provided to DCHC MPO for projects to reduce congestion and improve air quality; and

WHEREAS, Surface Transportation Block Grant – Direct Attributable (STBG-DA) funds are provided to DCHC MPO for transportation projects and planning activities; and

WHEREAS, the DCHC MPO approved FFY23 CMAQ funds for TIP # TL-0018 on September 14, 2022; and approved FFY23 STBG-DA funds and FFY23 CMAQ funds for TIP# TL-0025 on September 14, 2022;

WHEREAS, the Federal Transit Administration (FTA) administers most transit projects through the FTA's Urbanized Area Formula Grant Program; and

WHEREAS, in order for local governments to receive CMAQ or STBG-DA funds for transit projects, the Federal Highway Administration (FHWA) must transfer the funds to the FTA; then

NOW, BE IT THEREFORE RESOLVED that the Durham-Chapel Hill-Carrboro Metropolitan Planning Organization Board hereby requests that the Federal Highway Administration transfer the CMAQ and STBG-DA funds to the Federal Transit Administration for projects described on the attached able as soon as it is authorized to do so provided here on this, the 14th day of September, 2022.
