DRAFT FY 2016-2025 TIP Amendment #2 Summary Sheet

For review & comment.

- **NCDOT (#P-5706 East Durham Siding):** This is a new project being added.

Project description: Norfolk Southern H Line, East Durham Siding. Construct extension to include combination of grade separations and closures at Ellis Road south end crossing (734737A), Glover Road crossing (734736T) in Durham.

- **NCDOT (#P-5710 Grade Separations at Blackwell Street and Mangum Street):** This is a new project being added.

Project description: Norfolk Southern H Line. Construct grade separations at Blackwell Street crossing (735229N) and US 15/501 Business/Mangum Street crossing (35231P) in Durham.

- **City of Durham (#C-5178 Sidewalks in Durham – Campus Walk Avenue and LaSalle Street):** This amendment updates the project schedule to delay construction from FY2015 to FY2016 because additional time was needed for right-of-way acquisition.

Project description: Construct sidewalks on Campus Walk Ave from Morreene Rd to LaSalle St. Construct sidewalks on LaSalle St from Kangaroo Dr to Erwin Rd in Durham. Planning, design, right of way, and construction are in progress by the City of Durham.

- **NCDOT (#I-3306A I-40):** This amendment updates the project schedule to accelerate the right-of-way phase from FY2023 to FY2021 and construction from FY2024 to FY2023.

Project description: Improvements including ITS along I40 from I85 to the Durham County line.

- **NCDOT (#U-5717 US 15/501 (at Garrett Road):** This amendment updates the project schedule to accelerate the right-of-way phase from FY2023 to FY2020 and construction from FY2024 to FY2023.

Project description: Convert the existing at-grade intersection at US 15/501 and Garrett Road to an interchange.

- **NCDOT (#U-5774 NC 54):** This amendment updates the project schedules for Break B, C, E, F, and H to delay the construction from FY2024 to FY2025 to allow additional time for the right-of-way acquisition and utilities phases.

Project Break description:

B: NC 54 from US 15/501 in Orange County to Barbee Chapel Road in Durham County

C: NC 54 from Barbee Chapel Road in Durham County to I-40

E: NC 54 and Farrington Road intersection – convert at-grade intersection to grade separated

F: NC 54 and I-40 interchange improvements

H: NC 54 from NC 751 to Fayetteville Road

- **NCDOT (#TE-5205 Durham-Orange Light Rail Transit):** This amendment updates the project schedule and funding to reflect the State of North Carolina's budget cap of \$500,000 per project for light rail projects.

Project description: Construct a light rail transit system from UNC Hospitals in Chapel Hill to NC 55 (Alston Avenue) in Durham.
