FOR THE DURHAM-CHAPEL HILL-CARRBORO URBAN AREA**

**WHEREAS**, Surface Transportation Program – Direct Attributable (STPDA) funds are provided to the DCHC MPO for transportation projects and planning activities; and

**WHEREAS**, the DCHC MPO approved FFY 2015 and FFY 2016 STP-DA funds for TIP# TA-4923, TA-5019A, TA-5154, TD-5272, TA-4726A, and TD-5155;

**WHEREAS**, the Federal Transit Administration (FTA) administers most transit projects through the FTA's Urbanized Area Formula Grant Program; and

**WHEREAS**, in order for local governments to receive STPDA funds for transit projects, the Federal Highway Administration (FHWA) must transfer the funds to the FTA; then

**BE IT THEREFORE RESOLVED** that the Durham-Chapel Hill-Carrboro Metropolitan Planning Organization Board hereby requests that the Federal Highway Administration transfer the Surface Transportation Program Direct Attributable (STP-DA) funds for FFY 2015 and FFY2016 to the Federal Transit Administration for projects described on the attached table as soon as it is authorized to do so provided here on this, the 12th day of August, 2015.
