

Projects are administered by Triangle West TPO member jurisdictions



Projects are almost exclusively bicycle, pedestrian, and transit modes



Funded using federal funding sources and typically have a 20% minimum non-federal match



NCDOT staff advise, approve, and oversee the expenditures of LAP funds

# Overview

In November of 2021, the Triangle West TPO Board adopted the TPO's Federal Funding Policy (updated Fall 2023).

Policy states that recipients will provide a brief report on the status of their LAP projects twice a year. In addition to projects funded through the TPO's Regional Flexible Funding (RFF), this report includes projects funded through STI/SPOT process.

#### RIGHT-OF-WAY PHASE

- Right-of-Way Acquisition
- Utility Location
- Receive Right-of-Way
  - Certification from NCDOT
- Prepare Contract
  Proposal and Estimate
  (PS&E)



#### CONSTRUCTION PHASE

- Advertise and Let Construction Contract
- Construction &
  Administration
- Final Inspection
- Final Reimbursement



- Project Closeout: 6




