SUBJECT: Revised SPOT 7.0, MTP Amendment, and TIP Adoption Timeline

Summary

An updated draft FY2024-2033 State Transportation Improvement Program (STIP) was released in early April 2023 and the Board of Transportation (BOT) is scheduled to adopt the STIP in June. Following this adoption, the Durham-Chapel Hill-Carrboro Metropolitan Planning Organization (DCHC MPO) will have three months to adopt their portion of the STIP, known simply as the Transportation Improvement Program (TIP).

It is a requirement for all projects in the first four years of the TIP to match the DCHC MPO Metropolitan Transportation Plan (MTP). As a result of recent swaps and other updates occurring through the STIP adoption, the MTP will need to be amended to match the TIP. This amendment process requires running AQ conformity analysis to ensure that transit activities are consistent with the air quality goals set forth in the Clean Air Act. To ensure that the TIP and MTP match, the amendment to the MTP will need to be processed prior to (or in tandem with) TIP adoption.

The adoption of the STIP also denotes the beginning of a new Strategic Prioritization of Transportation (SPOT) process cycle. SPOT is a data-driven approach for ranking projects across North Carolina where projects are scored based on mode of transportation, degree of impact (statewide, regional, division), and other critical factors. This process takes several years and determines the prioritization of projects in a future funding cycle. This upcoming SPOT cycle is the 7th iteration of the scoring process and high-scoring projects will be funded in the FY2026-2035 STIP.
