# RE: MPO BOARD DIRECTIVES + IIJA UPDATE + STAFF REPORT

This memorandum updates the board on their directives, the 2021 Infrastructure and Jobs Act's programs, and summarizes DCHC MPO Unified Planning Work Program (UPWP) tasks.

# **1. MPO BOARD DIRECTIVES**

# 2. INFRASTRUCTURE INVESTMENTS AND JOBS ACT INFORMATION

On November 6, 2021, Congress passed the Bipartisan Infrastructure Deal (Infrastructure Investment and Jobs Act) (IIJA), a once-in-a-generation investment in national infrastructure and competitiveness. Among the IIJA's goals are several transportation-related investments in electric vehicles and infrastructure, passenger rail, airports and ports, public transit, and roads and bridges.

The funding for these programs will be distributed by state through formula grants and competitive grants, each with their own timeline and application requirements. This standing memo seeks to update the MPO Board and DCHC MPO jurisdictions regularly to grant and funding opportunities as they arise.

# III – A – 3 Transportation Modeling

- Travel Regional Model Enhancements
  - ✓ In the quarter of FY23 the team continued to work towards moving TRMG2 into production mode, including ongoing coordination with the MPOs on network development, revisions and improvements to the transit project manager, and evaluation of model results. The TRMG2 model was unanimously approved by the TRM Executive Committee in November of 2022. We are currently quality testing the new transit

program manager and cleaning up coding on the transit route system. Once complete the model will be distributed to the sponsoring agencies for final review with the expectation that the TRM GitHub repository will be transferred to ITRE soon thereafter.

- ✓ The ITRE team is continuing to develop TRMG2 end user tools to improve access to, and application of model outputs. An investigation into the impact of TRMG2's shorter peak periods on transit ridership concluded with a recommendation to move to a 3-hour AM and PM peak period during the next major model update. We are making good progress on the investigation into improved performance measures for VMT and mode share and have developed several new reporting tools designed to better capture VMT measures. We initiated an investigation into improvements to the non-motorized and are evaluating a possible improvement that will allow for the evaluation of non-motorized projects. No progress was made on equity performance measures this quarter due to the departure of our student intern who was focused on that effort. Horizon Year Data Forecasts
